Jackson appeals from his conviction for conspiring to commit bank fraud and making false statements to a federally insured bank. His counsel has filed a brief in accordance with Anders v. California, 386 U.S. 738 (1967). Jackson did not file a supplemental brief, despite a request to do so. Our review of the record discloses that there are no meritorious issues for appeal. Accordingly, we affirm. 2 Jackson and three codefendants were charged with conspiracy and a number of related offenses related to a scheme to obtain \$161,000 from a bank by having a co-conspirator fraudulently represent to the bank that her son was the owner of certain property. In exchange for his assistance in committing the fraud, the co-conspirator's son would forgive a loan in the amount of \$161,000. Jackson and his codefendants were convicted by a jury on 3da54e8ca3
